WAIVER OF LIABILITY, RELEASE AND INDEMNITY AGREEMENT

Each of the undersigned acknowledges that there are certain inherent risks related to recreational activities, including those involving horses, such as horseback riding and related activities, as well as risks involved with animals and their related facilities. These inherent risks can include bodily injury or death from using, riding, or being in close proximity to horses. Furthermore, the horse, rider, and bystanders can be injured during normal use, training, schooling, or competition. In consideration of the services to be performed by ALISON KOENIG and its agents, employees, and representatives, and all affiliated persons and organizations (hereinafter the "MANAGER"), and other good and valuable consideration, the undersigned participants (hereinafter collectively the "PARTICIPANT" whether one or more) agree to indemnify and hold harmless the MANAGER for any loss, liability, damage, or cost the PARTICIPANT may incur due to the negligence or advice of the MANAGER, or transportation to and from premises, including loss or damage to the PARTICIPANT's property, including horse(s) and other personal property. PARTICIPANT expressly agrees that this provision of this waiver, release and indemnity agreement is intended to be as broad and inclusive as permitted by the laws of the State of Tennessee, and that if any portion hereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full force and effect.

PARTICIPANT warrants and represents to MANAGER that PARTICIPANT and/or horse(s) is/are in good health and fit for training or riding sessions to be provided at PARTICIPANTs premises. Furthermore, PARTICIPANT agrees to indemnify and hold MANAGER harmless regarding pre-existing conditions of PARTICIPANT and/or horse(s).

This waiver and release shall be binding upon the undersigned PARTICIPANTS and their spouses, legal representatives, heirs and assigns, regarding all liability for any and all losses, or damages and claims and demands, whether for injuries to persons or loss of life, or damage to property arising out of acts or omissions of the MANAGER, including the negligence of the MANAGER. By signing this document, the PARTICIPANT is voluntarily accepting the risk of the MANAGER's potential negligence in traveling to and from, and participating in horseback riding and/or training sessions with the MANAGER.
